1. Croeso ac Ymddiheuriadau /Welcome and Apologies

The Chairman welcomed everyone to the meeting. There were no apologies.

4. Materion Personol / Personal Matters

CC Clive Davies was congratulated on his 'Activist of the Year Award' from Plaid Cymru.

7. Ceisiadau Cynllunio / Planning Applications

A190168 Land off B4570 Llangoedmor

Erection of new detached two storey building, double garage and retail unit under the rural enterprise policy (TAN6). Works to include new vehicular access to existing B4570 and external accommodation including parking and turning area for the proposed retail unit parking and turning are for dwelling and amenity spaces serving the new dwelling.

The Community Council supported the application.

Housing

CC Clive Davies advised that in the LDP2 both Penparc and Llechryd might be redefined to accept larger allocations of housing. It was asked that the Community Council be kept informed of any proposed changes.

8. County Councillor's Report

CC Clive Davies advised that the application for a pet crematorium in the old Chapel would go to Planning Committee. The application at Ty Ni, Tyfri, Llechryd had been refused. He had been appointed Deputy Mayor of Cardigan Town Council and Deputy Chair of Ceredigion County Council Licensing Committee. He was pleased to report that County Council officers would be in attendance at the event for victims of flooding at the Coracle Hall on 18th April, when further support would be offered. CCTV

was to be used in Cardigan again and he was looking a project whereby low frequency sensors might be used to help to tackle rural crime. He was made aware of ongoing problems in the Coedmor area. He advised that the Active Travel mapping for Ceredigion would be updated no later than Feb 2021.

Concern was again expressed that the garage did not appear to provide litter bins for those using its services.

Cllr S Kings advised he had attended a brush cutter course and hoped to have access to equipment owned by CCC in order to help maintain footpaths in the area. He hoped to have the opportunity to view the definitive footpath map for the area.

SLCC Meeting
