6. County Councillor's Report

CC Clive Davies confirmed that Ceredigion County Council would not implement a 40mph speed limit at the crossroads at Croes Y Llan as it did not currently meet the criteria. This would be reviewed by CCC in 12 months. He queried if the Council would allocate monies in its budget for match funding for the construction of footways in Llechryd. He said volunteers were still needed to implement the Community Speedwatch scheme and advised that the telecoms mast behind the 7 Stars was to be erected under permitted development rights. He had received one nomination for consideration for an invitation to the Royal Garden Party. CC Clive Davies was thanked for his work. He then left the meeting.

Track quote

Cllr H Davies left the room during discussion and voting on this item.

Several companies had been asked to quote. One quote had been received from I and E Davies. Following discussion the Council agreed to accept the quote of £ 9263 + VAT for tarmacking of the path. The monies would be drawn from reserves.

Millennium Building quote

A number of companies had been asked to quote for the repair work to the roof of the building. One quote had been received for the works and it was noted that a further quote was expected. It was agreed to delegate authority the Chairman, Vice-Chair and Clerk to review the 2 quotes (both from reputable, well know local businesses) and allocate the contract in order to get the process underway. Monies would be taken from reserves if the works could not be covered from the general maintenance budget.

Grass cutting quotes

The Clerk had provided a table showing the various contractors and associated costs for the 2018/19 contract. One quote was provided to the Clerk at the meeting but having considered the quote it was agreed that there was insufficient information enclosed with the quote to add it to the list of possible contractors. Following discussion it was agreed that the Clerk would seek references for the preferred contractor and liaise with the Chairman and Vice-Chair to review these and offer the contract if the references received were good. The contract would be offered on the basis that the contractor 'disposed of arisings from any works in a manner complying with current waste regulations'.

Plough

A number of companies had been contacted with regard to the work. 2 quotes had been received. Following discussion it was agreed to offer the contract for removal and refurbishment to L J Services Powder Coating. It was noted that St Dogmaels Community Council had used the company as had a local farm known to the Clerk. Reserves would be used if the general maintenance budget did not cover the costs.

Budget 2018/19

The Council had run through the proposed figures at the December 2017 meeting and with works now quoted and allocated the Clerk could provide a clearer estimate of the Council's financial situation at year end. It was noted that Community Council could only fund highways footway work under s137 the limit for which was set at £7.86 per elector 918 electors as at 5.1.18 = .£7215.48. Following discussion, in which the need for some reserves was agreed, Cllr Mrs E Davies proposed that a precept of £30,000 be requested. Seconded Cllr H Davies, carried unanimously.

To note CCC response re the request for a speed limit at Croes-Y-Llan crossroads as detailed in the County Cllrs report.

The Clerk would contact Tai Ceredigion to see if the planters could be placed ready for spring planting. She advised that if the Council wished to place a bench by the bus stop this would also have to be agreed by Tai Ceredigion and the bin adjacent the bus stop might need to be moved. It was agreed that Cllrs would look at the site prior to the February meeting.
