6. County Cllr's Report

CC Clive Davies noted that works would be undertaken to deal with ash dieback. Most instances for the County Council were on highways. The County Council was rated 4th in Wales for successful recycling although fly tipping had risen during the pandemic. He had received reassurance that there was no intention of making cuts to the ambulance service in the south of the county. He noted that the River Teifi was close to compliance levels for phosphates. He noted that works on the B4570 should be finished in March. He was disappointed to report that insufficient volunteers had come forward to enable a speedwatch group to the formed in Llechryd. He and the Clerk had been exchanging information with a County officer with regard to a possible Dogwatch scheme. He was very pleased to report that the fund for repairs at Mwnt church, following vandalism, had far exceed expectations. Any monies over and above those required for the repairs would be transferred to a general maintenance fund. NRW did not have the funds to clear the bridge until after the summer, the site was considered low risk due to the limited number of properties that were affected.

The recent traffic fatality in the village was noted with regret.

The defibrillator had been checked and returned to its site at the toilet block. It was queried if some kind of label could be attached to the machine to indicate ownership. CC Clive Davies would request, at the next PACT meeting that where a defibrillator was removed by the Police it should be returned ASAP.
