Cllr R Davies also advised that CCC Officers had undertaken a site visit with regard to fencing adjacent Coedmor verges. All barbed wire had now been removed but sections of fencing had subsequently been cut and vandalised.

6. County Cllr's Report

CC A Edwards advised that Natural Resources Wales was to clear the bridge having been put under local pressure to do so. She requested that all incidents of dog fouling be reported via CLIC as if no reports were received it was assumed that there were no local issues. It was hoped that a prosecution with regard to dog fouling, in a neighbouring community would highlight the issues and the possible penalties. She noted the frustration that the CLIC system did not record the progress of a request other than it had been assigned to the appropriate department. There were numerous issues with regard to the impact of rising costs on County services but she was an advocate for better services for mental health and young people. She noted the complaints about refused collections on the small roads and lanes not served by the refuse lorries. The 30mph to 20mph consultation should be coming out soon. Having met with CCC Officers she noted that they were still satisfied with their decisions with regard to fencing adjacent Coedmor lane.

9.2.5 Replacement climbing frame - will remain property of CC

The following were agreed in response to Sovereigns response to the RoSPA play inspection report:

On Page 19The loose post was not acceptable in a new installation. There should be no requirement to monitor the loose post as it was unclear at what point Sovereign would consider it was no longer its responsibility. Require to address.

On Page 20, not part of the issues with installation.

Page 20 the comment that timber is a natural product, and some shaking (cracking)/splintering can occur after time, or sometimes immediately in warm weather was noted. However there were local instances where inappropriate timber had been used for play equipment. If the cracks extend to a 'finger trap issue' or the posts show signs of rot they will have to be replaced. To be raised again with Sovereign and their further comment and commitment to replacing said timbers if issues progress, obtained.

Chairman's signature:

On Page 21, the report references to the timbers, and the poor finish. The timbers can be sanded down as part of your weekly maintenance inspection. However, I will also make a note for the team that will attend site to address the surfacing not being level, to sand down any necessary timbers. Page 21 also refers to trip points on the surfacing, the recommended action for this it to make the ground level. I will open a case and arrange for someone to attend site and make this surface level.

A date has been requested for the works to be undertaken.

No reference to the concerns about the quality of the installed safety surface which needs to be raised again with them in the response.
