## **Council News**

### **Playground**

The Council continued to operate the playground at Llechryd Playing Fields during the year. The Playing Fields are run through the Llechryd Playing Fields Association, a charity of which the Council is the sole trustee.

Dog fouling continues to be a problem around the playing fields area and the Council urges residents to pick up any dog waste to keep the area safe for local children.

### **Events**

The Council run a number of successful events for local residents during the course of the year.

#### Health Awareness

A health awareness event was held at the Coracle Hall Llechryd with a number of health professionals attending to give advice to local people.

#### Remembrance

The Community paid its respects on Remembrance Sunday by the laying of a wreath at the Llechryd War Memorial.

#### Christmas Lights

The Christmas lights were again erected on the tree near to the school. Unfortunately, the lighting up ceremony had to be abandoned as a result of adverse weather conditions with the arrival of Storm Darragh. Many thanks to Barcud for permission to display the lights on the tree.

#### Senior Citizens Christmas Dinner

The Council hosted a Christmas Dinner for senior citizens at the Coracle Hall in Llechryd. The event was well attended and the senior citizens were entertained by local school children.

#### Cardigan Mayor Ceremony

The Chairman of the Council represented the Council at the Cardigan Mayor making ceremony.

### **Flooding and Adverse Weather Incidents**

The Council wishes to thank those volunteers who form the local Resilience Groups who assist residents who are affected by these events.

The Council continues to work with the appropriate authorities to ensure the river and bridge in the area are properly maintained.

### **Defibrillators**

The Council continues to maintain and fund two defibrillators in the area. One in Llechryd and one in Llangoedmor.

### **Highways**

The Council continues to lobby to ensure appropriate road safety in the area.

**St Davids Holy Cross Church**

The Council continues to work with the church in Wales to find a satisfactory way to reopen the churchyard.

**Memorial Bench**

The Council installed a memorial bench in Llechryd during the year.

# Finance

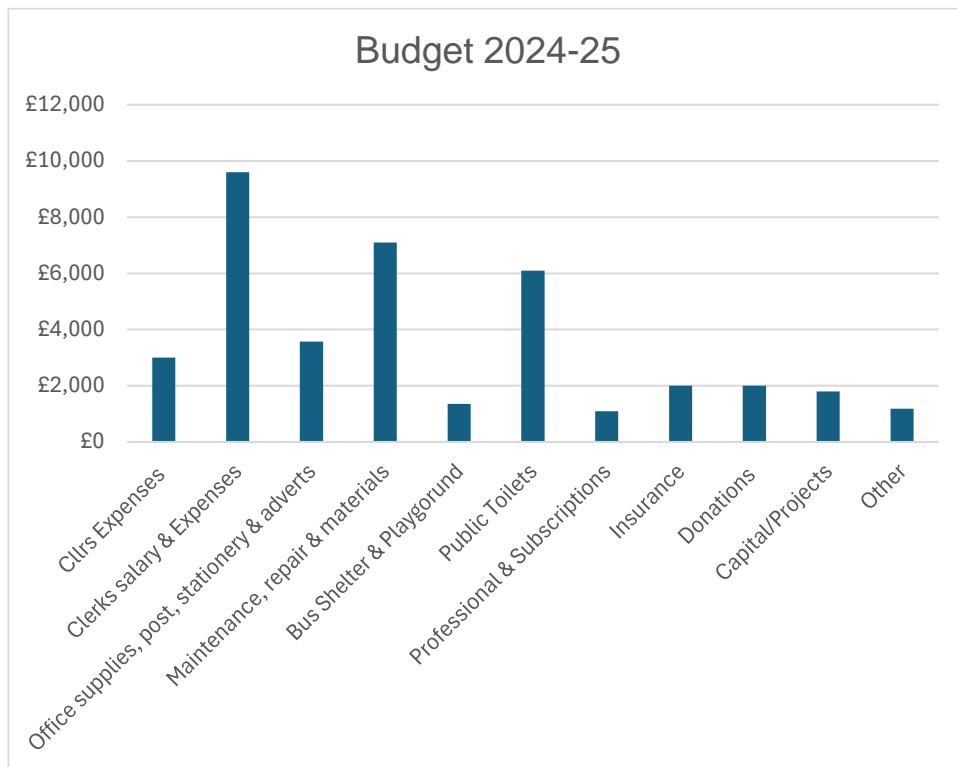
## 2024-25 Budget

### Precept £32,400

The Council set a budget for the 2024-25 Financial of £38,796. This is analysed by budgetary area in Table 1.

The budget was financed by raising a precept of £32,400, expected income of £1,000 and the release of unutilised reserves amounting to £5,396.

## 2024-25 Reported Outturn

In the 2024-25 Financial Year the Council received income of £33,999 and spent £21,342 during the year. This is summarised in Table 2.

During the 2024-25 Financial Year the Council had a surplus of income over expenditure of £12,657.

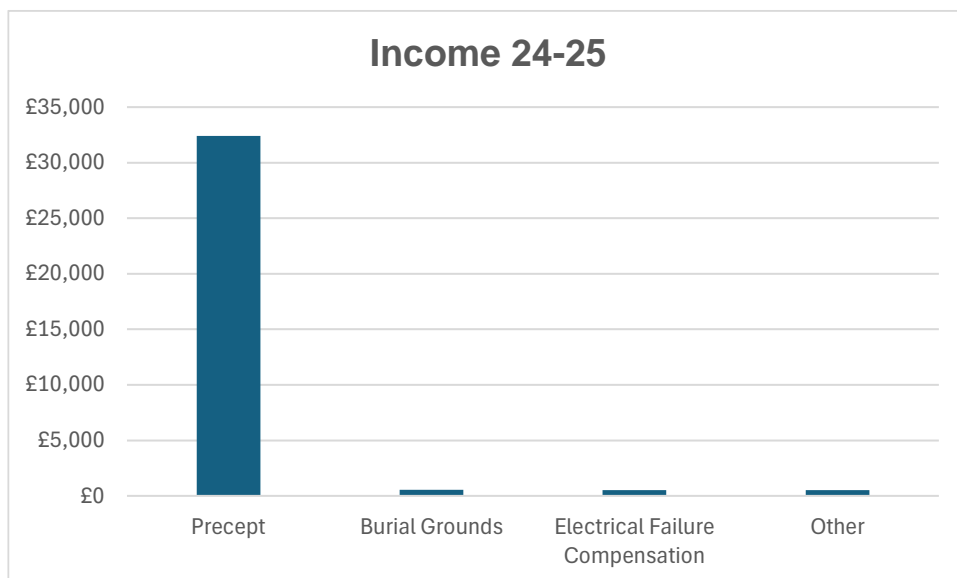

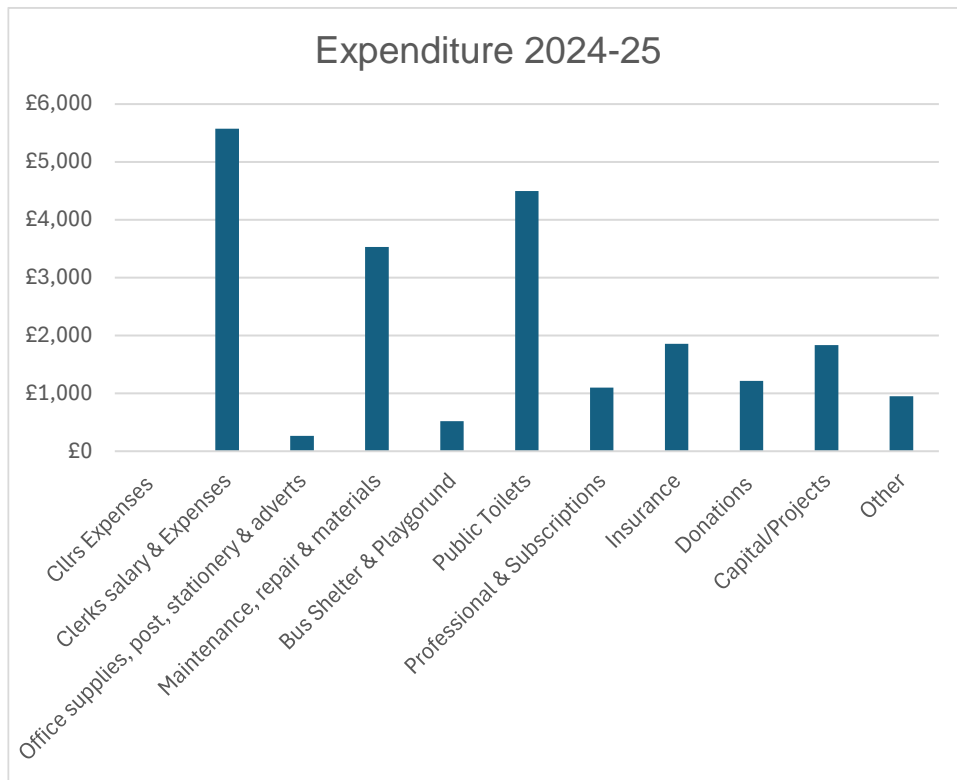
**2024-25 Income**

## Reserves

At 31<sup>st</sup> March 2025 the Council held £94,685 of reserves. A breakdown of these reserves is set out in Table 5. As can be seen £60,500 of the reserves that are not ring fenced are committed to capital works.

## **LLangoedmor Community Council**

Llangoedmor Community Council meets on 1<sup>st</sup> Monday of the month at 7p.m (excluding Bank Holidays – a list of meetings is available on the website). The first 10 minutes are allocated to any member of the community who wishes to raise a matter with the Community Council.

Currently meetings are held at the Coracle Hall (unless otherwise advertised) with access via Zoom. The agenda and papers for meetings are available on the Community Council's website ( <http://llangoedmorcc.org.uk/> ) under agenda and supporting documents

### **What is a Community Council and what does it do?**

- A Community Council is the most local level of government in the community.
- Community councils (equivalent of Parish Councils in England) are legal bodies created by Act of Parliament and have the right to levy a local tax (called a Precept) on every household.
- Decisions of the Council are made by Community Councillors who are elected by local voters.
- The role of a Community Council is to promote their local areas, represent its interests and support the work of local community groups.
- Community Councils also provide a limited range of local public services which vary according to the size of the community council. However, the responsibilities of Community Councils are limited, as most local government services are undertaken by the County Council.

### **What does Llangoedmor Community Council (LCC) do?**

There is a lot of confusion about who runs which public services. This is understandable as it is not always easy to work out who does what and why. However, generally, most local government services are the responsibility of Ceredigion County Council (CCC).

LCC lobbies for community actions both locally and nationally.

LCC acts as a non-statutory consultee on planning applications. The planning authority is CCC.

LCC offers a grant funding scheme for local community organisations. More information can be found on the Council's website at <http://llangoedmorcc.org.uk/grant-funding/>

The Council encourages eligible organisations to apply for grant funding.

### **Llangoedmor Community Council has sole responsibility for:**

- The toilet block in the Coracle Hall car park
- The Millennium building by Llechryd bridge
- The bus shelters (apart from Lady Road)
- St David's Holy Cross Church, Llechryd
- Maintenance of two defibrillators
- Remembrance Sunday wreath laying ceremony

**Llangeodmor Community Council is sole managing Trustee through the Llechryd Playing Fields Association for:**

- Llechryd playing field
- Llechryd play area
